2. In the event of any proceedings being commenced or demands being made, against you or any of your servants of agents in connection with the ship proceeding and giving delivery of the cargo as aforesaid, to provide you or them on demand with sufficient funds to defend the same.

If, in connection with the delivery of the cargo as aforesaid, the ship, or any other ship or property in the same or associated ownership, management of control, should be arrested or detained or should the arrest or detention thereof be threatened, or should there be any interference in the use or trading of the vessel (whether by virtue of a caveat being entered on the ship's registry or otherwise howsoever), to provide on demand such bail or other security as may be required to prevent such arrest or detention or to secure the release of such ship or property or to remove such interference and to indemnify you in respect of any liability, loss, damage or expense caused by such arrest of detention or threatened arrest of detention or such interference, whether or not such arrest or detention or threatened arrest or detention or such interference may be justified.
4. The liability of each and every person under this indemnity shall be joint and several and shall not be conditional upon your proceeding first against any person, whether or not such person is party to or liable under this indemnity.
5. This indemnity shall be governed by and construed in accordance with Indian law and each and every person liable under this indemnity shall at your request submit to the jurisdiction of the high court of Chennai, India

Notwithstanding any thing contained above, We also hereby unconditionally and irrevocably, accept and agree that, you as carrier and/or as carrier's agents, shall have the absolute and sole discretion to invoke this indemnity, at any place of your choosing, including in a court of competent jurisdiction, at any place, country including the place, where this indemnity has been submitted by us and we agree to abide by the terms of the indemnity thus submitted..
